

Tintern Visitor Experience Survey Prize Draw Terms and Conditions

This prize draw is organised by Visit Monmouthshire, Monmouthshire County Council, County Hall, The Rhadyr, Usk, NP15 1GA, to generate feedback from visitors to inform improvements to visitor infrastructure in Tintern.

How to enter

1. The prize draw is free to enter and no purchase is necessary, but completion of the survey questionnaire and provision of a valid email address are requirements to be entered into the prize draw.
2. Entries received after the stated closing date will not be accepted.
3. Monmouthshire County Council will not accept responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
4. By submitting an entry, you are agreeing to be bound by these Terms and Conditions. If you have any questions, please contact tourism@monmouthshire.gov.uk
5. Monmouthshire County Council reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these terms and conditions.

Eligibility

6. The prize draw is open to all except Visit Monmouthshire staff members, their families, agents or any third party directly associated with administration of the prize draw.
7. Entrants under 18 must get consent from their parent(s) or legal guardian(s) before entering. The parent(s) or legal guardian(s) of entrants under 18 agree to these Terms and Conditions on behalf of the entrant.
8. Only one entry per person is permitted.
9. In entering, you confirm that you are eligible to do so and eligible to claim any prize you may win. Monmouthshire County Council may require you to provide proof that you are eligible to enter the prize draw.
10. Monmouthshire County Council reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize draw.

The Draw

11. A winner will be chosen by random draw performed by a computer process within one month of the prize draw ending.
12. The winner will be notified by email (using details provided at entry) by Cadw within 14 days of being selected. If a winner does not respond to Cadw within 21 days of being notified, then the winner's prize will be forfeited and Monmouthshire County Council will be entitled to select another winner in accordance with the process described above.
13. The winner will be expected to collect the prize from a Cadw site of their choice. Details of this collection process will be contained within the Cadw email.

14. The prize is non-exchangeable, non-transferable and no cash alternative is offered. Monmouthshire County Council reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond Monmouthshire County Council's control makes it necessary to do so.

15. The decision of Monmouthshire County Council regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.

16. The winner's name and county can be obtained by sending an email to tourism@monmouthshire.gov.uk within 60 of days after the date of the closing of the prize draw.

17. Monmouthshire County Council reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

Limitation of liability

18. Insofar as is permitted by law, Monmouthshire County Council, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of Monmouthshire County Council, its agents or distributors or that of their employees. Your statutory rights are not affected.
